The Secretary of State for Health in relation to England, and the National Assembly for Wales in relation to Wales, in exercise of the powers conferred by sections 11(1), (2) and (4) of, and paragraph 9(7)(b) of Schedule 5 to, the National Health Service Act 1977 <sup>M1</sup>, and now vested in them and of all other powers enabling them in that behalf hereby make the following Order:

## Citation, commencement and interpretation

1.—(1) This Order may be cited as the NHS Business Services Authority (Awdurdod Gwasanaethau Busnes y GIG) (Establishment and Constitution) Order 2005 and shall come into force on 1st October 2005.

(2) In this Order—

“the Act” means the National Health Service Act 1977;

“appropriate authority” means—

- (a) in relation to England, the Secretary of State, and
- (b) in relation to Wales, the National Assembly for Wales;

“the Authority” means the NHS Business Services Authority (Awdurdod Gwasanaethau Busnes y GIG) established by this Order;

“the NHS Bursary Scheme” means the NHS Bursary Scheme established pursuant to section 63 of the Health Services and Public Health Act 1968; and

[<sup>F2</sup>“NHS Injury Benefits Scheme” means any scheme making provision for benefits for health staff in respect of injury or disease and established pursuant to section 10 of the Superannuation Act 1972, but excluding any scheme making provision for the early payment of a pension, allowance or gratuity in respect of ill-health;]

[<sup>F3</sup>“the NHS Pension Scheme” means any scheme making provision for pensions, allowances, gratuities or compensation for premature retirement for health staff and established pursuant to section 10 or section 24 of the Superannuation Act 1972, but excluding the NHS Injury Benefits Scheme;]

[<sup>F2</sup>“orthodontic appliance” means a device used in the mouth to move or immobilise the teeth in order to correct or prevent malocclusion;]

- (b) a general dental services contract; or
- (c) a personal dental services agreement;]

[<sup>F5</sup>“the Social Care Bursary Scheme” means the Social Care Bursary Scheme established pursuant to section 67(4)(a) of the Care Standards Act 2000;]

[<sup>F2</sup>“treatment” means all proper and necessary dental treatment which a provider of relevant primary dental services usually undertakes for a patient and which the patient is willing to undergo, including examination, diagnosis, advice on and planning of treatment, preventive care and treatment, periodontal treatment, conservative treatment, surgical treatment, the supply and repair of dental appliances and orthodontic appliances, orthodontic treatment, the taking of radiographs, the provision of sedation in connection with such treatment, the supply of listed drugs and the issue of prescriptions whether or not provided on referral to the provider of relevant primary dental services.]

### Establishment of the Authority

2. There is hereby established a Special Health Authority which shall be known as the NHS Business Services Authority (Awdurdod Gwasanaethau Busnes y GIG).

### [<sup>F6</sup>Functions of the Authority

3. Subject to and in accordance with such directions as the appropriate authority may give to the Authority, the Authority shall perform such functions in connection with—

- (a) the administration of—
  - (i) schemes relating to the provision of assistance with NHS charges;
  - <sup>F7</sup>(ii) . . . . .
  - (iii) the NHS Bursary Scheme in England;
  - (iv) the NHS Injury Benefit Scheme; <sup>F8</sup>...
  - (v) the NHS Pension Scheme; [<sup>F9</sup>and]
  - [<sup>F10</sup>(vi) the Social Care Busary Scheme in England;]
- (b) the assessment of the performance of dentists providing services under general dental services contracts and personal dental services agreements;
- (c) assisting
  - (i) the Secretary of State in relation to specified Department of Health [<sup>F11</sup>and Social Care] programmes; and
  - (ii) specified Special Health Authorities in the exercise of their functions,

by the provision of business services and facilities and the supply of staff;

- (d) the collation and provision of information about relevant primary dental services, pharmaceutical services and local pharmaceutical services;
- (e) the development and promotion of arrangements for the clinical governance of services provided under general dental services contracts and personal dental services agreements;

## Constitution of the Authority

- 4.—<sup>F19</sup>(1) The Authority shall consist of—
- (a) a chairman;
  - (b) not less than two and not more than <sup>F20</sup>five] members who are not officers of the Authority in addition to the chairman; and
  - (c) not more than <sup>F21</sup>six] members who are officers of the Authority including the persons who for the time being hold the office of chief executive and director of finance.

<sup>F22</sup>(2) The members mentioned in paragraph (1)(b) above shall include a person with particular experience suited to the interests of Wales.]

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order provides for the establishment and constitution of a Special Health Authority, to be known as the NHS Business Services Authority (Awdurdod Gwasanaethau Busnes y GIG) (“the Authority”), to exercise functions, in England and Wales, in connection with the processing of payments made to providers of goods and services to the health service, the development of, and planning for the coordination of, business and regulatory services within specified parts of the health service and such other functions as, in relation to England, the Secretary of State and, in relation to Wales, the National Assembly for Wales may direct it to perform.

Article 2 of the Order establishes the Authority, the functions of which are described in article 3 and are to be specified more particularly in directions given by the Secretary of State, in relation to England, and the National Assembly for Wales, in relation to Wales. Provision is also made for the constitution of the Authority (article 4) and for the remuneration of its members (article 5).
