# THE GENERAL MEDICAL COUNCIL (CONSTITUTION OF PANELS AND INVESTIGATION COMMITTEE) (AMENDMENT) RULES 2005

The General Medical Council, in exercise of its powers under paragraph 19B of Schedule 1 to the Medical Act 1983(a), and of all other powers enabling it in that behalf, hereby makes the following Rules:—

### Citation and commencement

1. These Rules may be cited as the General Medical Council (Constitution of Panels and Investigation Committee) (Amendment) Rules 2005 and shall come into force on the 1st April 2005.

### Consequential amendment

**2.** In the General Medical Council (Constitution of Panels and Investigation Committee) Rules 2004(**b**) in rule 6 (quorum) and rule 7 (validity of proceedings), after "a Panel" insert "a Registration Decisions Panel".
