**The West Hertfordshire Hospitals National Health Service Trust
(Transfer of Trust Property) Order 2005**

Made - - - - - *26th February 2005*
Laid before Parliament *8th March 2005*
Coming into force - - - *31st March 2005*

The Secretary of State for Health, in exercise of the powers conferred on him by sections 92(1), 96(1) and 126(4) of the National Health Service Act 1977(a) and of all other powers enabling him in that behalf, having regard to proposed changes in the arrangements for the administration of the facilities of the West Hertfordshire Hospitals National Health Service Trust(b) and having consulted that Trust and the East and North Hertfordshire National Health Service Trust(c) in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the West Hertfordshire Hospitals National Health Service Trust (Transfer of Trust Property) Order 2005 and shall come into force on 31st March 2005.

(2) In this Order—

- “the old Trust” means the West Hertfordshire Hospitals National Health Service Trust;
- “the new Trust” means the East and North Hertfordshire National Health Service Trust; and
- “the trust property” means the property specified in the schedule of trust property prepared and agreed by the old Trust and the new Trust and signed on behalf of the old Trust on 29 November 2004 and on behalf of the new Trust on 17 January 2005.

The functions of the Secretary of State under the above mentioned powers are transferred to the National Assembly for Wales under article 2(a) of the National Assembly for Wales (Transfer of Functions) Order 1999 S.I. 1999/672, as amended by section 66(5) of the 1999 Act.

Transfer of trust property

2.—(1) On the date that this Order comes into force the trust property, and any rights and liabilities arising from that property, shall be transferred from the old Trust to the new Trust.

(2) In any instrument relating to the trust property, any reference to the trustees of the trust property or, as the case may be, the old Trust shall be construed as a reference to the trustees of the new Trust or, as the case may be, the new Trust.
