The Secretary of State makes the following Order in exercise of the powers conferred by section 40(2) and (4) of the London Olympic Games and Paralympic Games Act 2006<sup>(a)</sup>:

**Citation**

1. This Order may be cited as the London Olympic Games and Paralympic Games Act 2006 (Commencement No. 2) Order 2007.

**Provisions coming into force on 2nd April 2007**

2. The following provisions of the London Olympic Games and Paralympic Games Act 2006 shall come into force on 2nd April 2007—

- (a) paragraph 12 of Schedule 3,
- (b) paragraph 13 of Schedule 3, to the extent that it inserts section 8B(2) and (3) into the Olympic Symbol etc. (Protection) Act 1995<sup>(b)</sup>, and
- (c) paragraph 14 of Schedule 3.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order brings the following provisions of the London Olympic Games and Paralympic Games Act 2006 into force on 2nd April 2007:

- paragraph 12 of Schedule 3, which inserts section 8A into the Olympic Symbol etc. (Protection) Act 1995 (“1995 Act”),
- paragraph 13 of Schedule 3, to the extent that it inserts section 8B(2) and (3) into the 1995 Act, and
- paragraph 14 of Schedule 3, which inserts sections 12A and 12B into the 1995 Act.
