The Secretary of State, in exercise of the powers conferred by section 128(2) of the Serious Organised Crime and Police Act 2005(a), makes the following Order:

1.—(1) This Order may be cited as the Serious Organised Crime and Police Act 2005 (Designated Sites under Section 128) (Amendment) Order 2007 and shall come into force on 1st June 2007.

(2) This Order extends to England and Wales only.

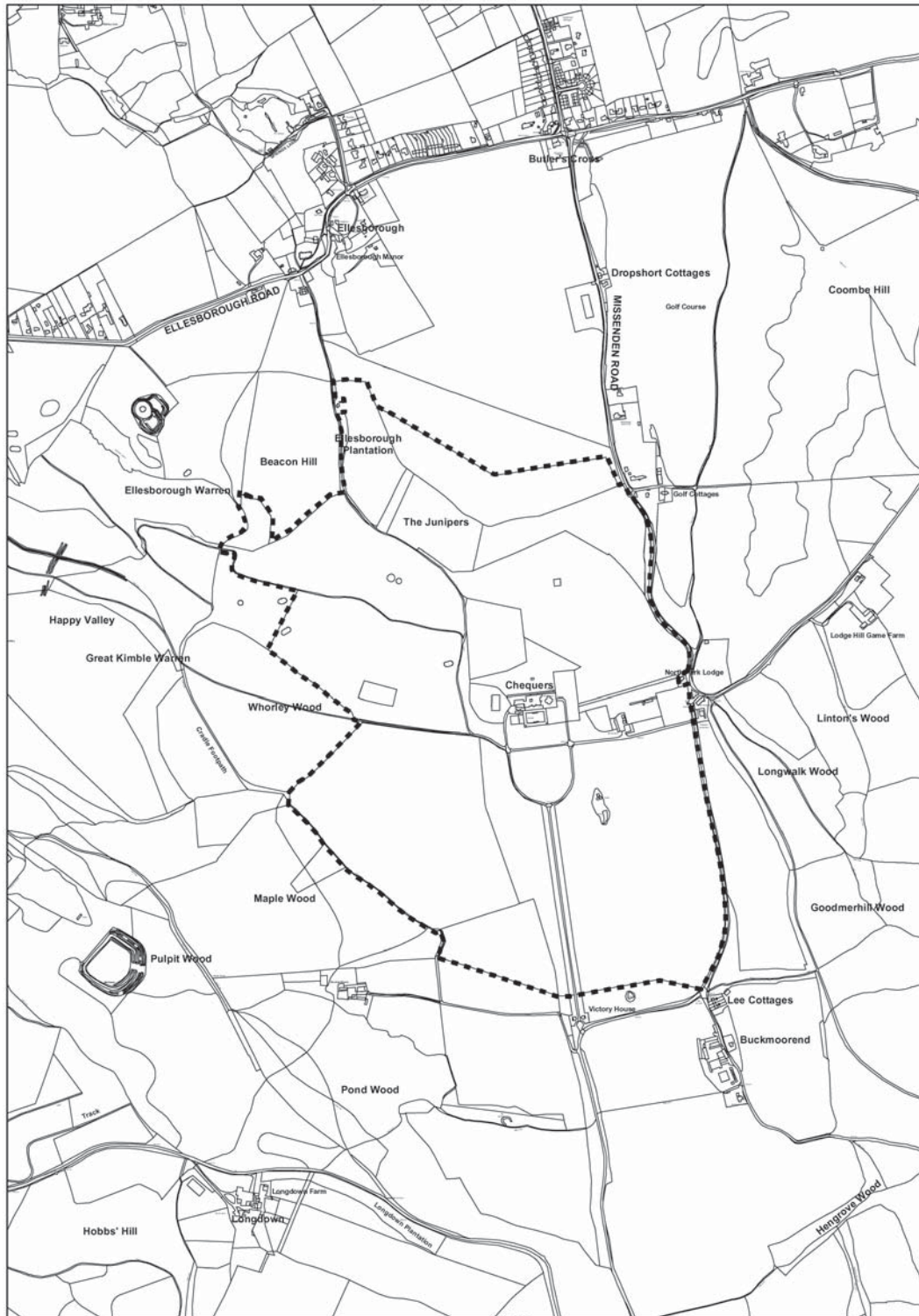
