**The Castle Point (Parish Electoral Arrangements) Order 2007**

*Made* - - - - *25th January 2007*

*Coming into force in accordance with article 1(2)*

Castle Point Borough Council, under section 12(a) of the Local Government and Rating Act 1997(b) (“the 1997 Act”), have sent to the Electoral Commission(c) proposals dated October 2006 for electoral arrangements in the proposed parish of Canvey Island(d) in the borough(e) of Castle Point:

The Electoral Commission have decided to give effect to those proposals:

Accordingly, the Electoral Commission, in exercise of the powers conferred by sections 14(f) and 23(g) of the 1997 Act, make the following Order:

**Citation and commencement**

1.—(1) This Order may be cited as the Castle Point (Parish Electoral Arrangements) Order 2007.

(2) This Order comes into force—

- (a) for the purpose of proceedings preliminary or relating to the elections of parish councillors for the parish of Canvey Island, to be held on the ordinary day of election of councillors in 2007, on the day after that on which it is made;
- (b) for all other purposes, on the ordinary day of election of councillors 2007.

**Interpretation**

2. In this Order—

“ordinary day of election of councillors” has the meaning given by section 37 of the Representation of the People Act 1983(h); and

“registration officer” means an officer appointed for the purpose of, and in accordance with, section 8(a) of the Representation of the People Act 1983.

### **Elections for the parish of Canvey Island**

3. Elections of all parish councillors for the parish of Canvey Island shall be held simultaneously on the ordinary day of election of councillors in 2007(b).

### **Wards of the parish of Canvey Island**

4.—(1) The parish of Canvey Island shall be divided into six wards which shall be named Canvey Island Central, Canvey Island East, Canvey Island North, Canvey Island South, Canvey Island West and Canvey Island Winter Gardens.

(2) Each ward shall comprise the area of the district ward(c) bearing the same name.

(3) The number of councillors to be elected for each of Canvey Island Central, Canvey Island East, Canvey Island North, Canvey Island South and Canvey Island Winter Gardens wards shall be two, and for Canvey Island West ward shall be one.

### **Electoral register**

5. The registration officer for the borough of Castle Point shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order gives effect to proposals sent to the Electoral Commission for electoral arrangements for the new parish of Canvey Island, created within the borough of Castle Point by the Castle Point (Parish) Order 2006.

The new electoral arrangements apply in respect of parish elections to be held on and after the ordinary day of election of councillors in 2007.

Article 3 provides for parish elections in the parish of Canvey Island in 2007, and then to continue according to the established system of parish elections every four years.

Article 4 establishes the names and areas of the wards of that parish and the numbers of councillors for each ward.

Article 5 obliges the Electoral Registration Officer to make any necessary amendments to the electoral register to reflect the new electoral arrangements.
