**The Road Traffic (Permitted Parking Area and Special Parking  
area) (City of Manchester) (Amendment) Order 2007**

This Order is made in exercise of the powers conferred by paragraphs 1(1), 2(1) and 3(3) of Schedule 3 to the Road Traffic Act 1991(a).

Manchester City Council has applied to the Secretary of State for an Order to be made under paragraphs 1(1) and 2(1) of that Schedule with respect to part of its area.

The Secretary of State has consulted the chief officer of Greater Manchester Police in accordance with the requirements of paragraphs 1(3) and 2(3) of that Schedule and the Council on Tribunals in accordance with the requirements of section 8 of the Tribunals and Inquiries Act 1992(b).

Accordingly the Secretary of State for Transport makes this Order:

**Citation and commencement**

1. This Order may be cited as the Road Traffic (Permitted Parking Area and Special Parking Area) (City of Manchester) (Amendment) Order 2007 and shall come into force on 13th July 2007.

**Amendment of the Road Traffic (Permitted Parking Area and Special Parking Area) (City of Manchester) Order 1999**

2. Part 1 of Schedule 1 to the Road Traffic (Permitted Parking Area and Special Parking Area) (City of Manchester) Order 1999(c) is amended as set out in the Schedule to this Order.

Schedule 1 is amended by substituting a new Part 1 that omits a number of the roads previously excluded from the permitted parking and special parking areas designated by the principal order.
