The Secretary of State is designated <sup>M1</sup> for the purposes of section 2(2) of the European Communities Act 1972 <sup>M2</sup> in relation to persistent organic pollutants, dangerous substances, preparations and chemicals.

### 3.—(1) Subject to paragraph (2), the following is a competent authority—

(c) in Northern Ireland, the [<sup>F5</sup>Department for the Economy] and the [<sup>F6</sup>Department of Agriculture, Environment and Rural Affairs] acting alone or jointly.

(2) In relation to matters outside the competence of [<sup>F7</sup>the Northern Ireland Assembly], the competent authority is the Secretary of State.
