**The Lincolnshire Partnership National Health Service  
Trust (Transfer of Trust Property) Order 2007**

*Made - - - - 16th September 2007*  
*Laid before Parliament 21st September 2007*  
*Coming into force - - 1st November 2007*

The Secretary of State for Health makes the following Order in exercise of the powers conferred by sections 213, 217(2) and 272(8) of the National Health Service Act 2006<sup>(1)</sup>, having regard to changes in the functions of the Lincolnshire Teaching Primary Care Trust<sup>(2)</sup>.

**Citation, commencement and interpretation**

1.—(1) This Order may be cited as the Lincolnshire Partnership National Health Service Trust (Transfer of Trust Property) Order 2007 and shall come into force on 1<sup>st</sup> November 2007.

(2) In this Order—

“the old Trust” means the Lincolnshire Partnership National Health Service Trust<sup>(3)</sup>;

“the new Trust” means the Lincolnshire Teaching Primary Care Trust; and

“the trust property” means the property specified in the schedule of trust property prepared and agreed by the old Trust and the new Trust and signed on behalf of both the old Trust and the new Trust on 24<sup>th</sup> May 2007.

**Transfer of trust property**

2.—(1) On the date that this Order comes into force the trust property, and any rights and liabilities arising from that property, shall be transferred from the old Trust to the new Trust.

(2) In any instrument relating to the trust property, any reference in relation to the trust property to the trustees of the trust property or to the old Trust shall be construed as a reference to the new Trust.
