**The Staffordshire Ambulance Service National Health Service
Trust (Dissolution) Order 2007**

Made - - - - *18th September 2007*

Coming into force - - *1st October 2007*

The Secretary of State for Health makes the following Order in exercise of the powers conferred on him by section 273(1) of, and paragraph 28(1) of Schedule 4 to, the National Health Service Act 2006(a).

The Secretary of State for Health considers it appropriate in the interests of the health service to dissolve the Staffordshire Ambulance Service National Health Service Trust and has completed the consultation prescribed under paragraph 28(3) of Schedule 4 to the National Health Service Act 2006(b).

Citation and commencement

1. This Order may be cited as the Staffordshire Ambulance Service National Health Service Trust (Dissolution) Order 2007 and shall come into force on 1st October 2007.

Dissolution of NHS trust

2. The Staffordshire Ambulance Service National Health Service Trust established by the Staffordshire Ambulance Service National Health Service Trust (Establishment) Order 1991(c) is dissolved, and accordingly that Order, and the Staffordshire Ambulance Service National Health Service Trust (Establishment) Amendment Order 1997(d), are revoked.
