**The Drinking Milk (England) Regulations 2008**

**Interpretation**

2.—(1) In these Regulations—

“the 1990 Act” means the Food Safety Act 1990;

“Article 114(2)” means Article 114(2) of the Council Regulation;

“the Council Regulation” means Council Regulation (EC) No 1234/2007 establishing a common organisation of agricultural markets and on specific provisions for certain agricultural products (Single CMO Regulation);

“drinking milk” has the meaning given in point I(b) of [<sup>F2</sup>Part IV];

“food authority” does not include the appropriate Treasurer referred to in section 5(1) of the 1990 Act;

“milk” has the meaning given in point I(a) of [<sup>F2</sup>Part IV]; and

[<sup>F3</sup>“Part IV” means [<sup>F4</sup>Part 4 of Annex 7 to Regulation (EU) No 1308/2013 of the European Parliament and of the Council establishing a common organisation of the markets in agricultural products], as amended from time to time.]

“sell” includes possess for sale and offer, expose or advertise for sale.

(2) Other expressions used in these Regulations and in the Council Regulation [<sup>F5</sup>or Part IV] which are not defined in these Regulations have the same meaning in these Regulations as they have in the Council Regulation [<sup>F5</sup>or Part IV].
