PUBLIC PASSENGER TRANSPORT, ENGLAND AND WALES

The Public Service Vehicles (Registration of Local Services) (Amendment) (England and Wales) Regulations 2008

Made	5th June 2008
Laid before Parliament	12th June 2008
Coming into force	1st August 2008

The Secretary of State for Transport makes the following Regulations in exercise of the powers conferred by sections 52(1)(a) and 60(1)(e) and (1A) of the Public Passenger Vehicles Act 1981(**a**) and by sections 126(1) and 134 of the Transport Act 1985(**b**); and by virtue of the Department of Transport (Fees) Order 1988(**c**).

Representative organisations have been consulted in accordance with section 61(2) of the Public Passenger Vehicles Act 1981(d).

Citation, commencement and extent

1.—(1) These Regulations may be cited as the Public Service Vehicles (Registration of Local Services) (Amendment) (England and Wales) Regulations 2008 and shall come into force on 1st August 2008.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations increase the fee for the registration of, or the variation of the registration of, a local bus service. The fee for a local bus service other than a community bus service is increased from $\pounds 54$ to $\pounds 57$. This represents an increase of 5.6%. The fees were last increased on 1st April 2007.
