**ENVIRONMENTAL PROTECTION, ENGLAND**

**The Genetically Modified Organisms  
(England) (Amendments) Regulations 2008**

*Made - - - - 2nd October 2008*  
*Laid before Parliament 8th October 2008*  
*Coming into force - - 14th November 2008*

The Secretary of State for Environment, Food and Rural Affairs, being a Minister designated <sup>M1</sup> for the purposes of section 2(2) of the European Communities Act 1972 <sup>M2</sup> in relation to measures relating to the control and regulation of genetically modified organisms, makes the following Regulations in exercise of the powers conferred by that section.

**Title and commencement** **U.K.**

1. These Regulations may be cited as the Genetically Modified Organisms (England) (Amendments) Regulations 2008; they come into force on 14th November 2008.

**Amendments** **U.K.**

2. In regulation 8(1) of the Genetically Modified Organisms (Traceability and Labelling) (England) Regulations 2004 <sup>M3</sup>—

- (a) omit sub-paragraph (d);
- (b) in sub-paragraph (e), before “7” insert “ 6 or ”.
