# The Social Fund Winter Fuel Payment (Temporary Increase) Regulations 2009

Made	12th June 2009
Laid before Parliament	18th June 2009
Coming into force	21st September 2009

The Secretary of State for Work and Pensions makes the following Regulations in exercise of the powers conferred upon him by sections 138(2) and (4) and 175(1), (3) and (4) of the Social Security Contributions and Benefits Act 1992(a).

The Social Security Advisory Committee has agreed that proposals in respect of these Regulations should not be referred to it(**b**).

## Citation and commencement

**1.**—(1) These Regulations may be cited as the Social Fund Winter Fuel Payment (Temporary Increase) Regulations 2009.

(2) They come into force on 21st September 2009.

### Modification of the Social Fund Winter Fuel Payment Regulations 2000

**2.**—(1) For the purpose of making social fund winter fuel payments in respect of the 2009–10 winter, regulation 2 of the Social Fund Winter Fuel Payment Regulations 2000(c) (social fund winter fuel payments) is applied as if—

- (a) the references to  $\pounds 100$  (in both places) were to  $\pounds 125$ ;
- (b) in paragraphs (1)(i), (2)(a) and (3), the reference to £200 were to £250;
- (c) in paragraph (2)(b), the reference to  $\pounds 200$  were to  $\pounds 275$ ;
- (d) in paragraph (2)(b), the reference to  $\pounds 150$  were to  $\pounds 200$ ; and
- (e) the references to  $\pounds 300$  (in both places) were to  $\pounds 400$ .

(2) In this regulation, "the 2009–10 winter" means the winter which follows the qualifying week beginning on 21st September 2009.

3. The Social Fund Winter Fuel Payment (Temporary Increase) Regulations 2008(a) are revoked.

#### **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations modify the Social Fund Winter Fuel Payment Regulations 2000 to provide for an increase in winter fuel payments for winter 2009/2010.

They also revoke the Social Fund Winter Fuel Payment (Temporary Increase) Regulations 2008 which provided for an increase in payments for winter 2008/2009.

A full impact assessment has not been produced for this instrument as it has no impact on the private or voluntary sectors.
