### The Civil Aviation (Customs and Excise Airports) Order 2009

Made - - - - 30th June 2009

Coming into force - - 1st August 2009

The Secretary of State for Transport, in exercise of the powers under Article 136 of the Air Navigation Order 2005(1) and with the concurrence of the Commissioners of Revenue and Customs, makes the following Order:
