## The Environmental Permitting (England and Wales) (Amendment) Regulations 2009

### Citation, commencement and extent

- (a) may be cited as the Environmental Permitting (England and Wales) (Amendment) Regulations 2009;
- (b) come into force on 7th July 2009; and
- (c) extend to England and Wales only.
