**The Stratford-on-Avon (Related Alterations) Order 2009**

*Made* - - - - *6th March 2009*

*Coming into force in accordance with article 1(2) and (3)*

Under section 9(6) of the Local Government and Rating Act 1997<sup>(a)</sup> (“the 1997 Act”) Stratford-on-Avon District Council made proposals to the Electoral Commission for the related alteration of the boundaries of county electoral divisions and district wards within the Council’s area.

The Electoral Commission have decided to give effect to the proposals and in exercise of the powers conferred by section 14(1A) of the 1997 Act<sup>(b)</sup> make the following Order:

**Citation and commencement**

- 1.—(1) This Order may be cited as the Stratford-on-Avon (Related Alterations) Order 2009.
- (2) This Order, with the exception of article 4, comes into force—
  - (a) for the purpose of proceedings preliminary or relating to the elections of councillors for county electoral divisions, on the day after that on which it is made;
  - (b) for all other purposes, on the ordinary day of election of councillors in 2009.
- (3) Article 4 comes into force—
  - (a) for the purpose of proceedings preliminary or relating to the elections of councillors for district wards, on 15th October 2010;
  - (b) for all other purposes, on the ordinary day of election of councillors in 2011.

**Interpretation**

2. In this Order—

“ordinary day of election of councillors” has the meaning given by section 37 of the Representation of the People Act 1983<sup>(c)</sup>; and

“the 2006 Order” means the Stratford-on-Avon (Parishes) Order 2006<sup>(d)</sup>.

### **Related alterations of county electoral division boundaries**

3.—(1) Each area described in column 1 of Table 1 of the Schedule to this Order ceases to be part of the county electoral division named in column 2 of that Table and becomes part of the county electoral division named in column 3 of that Table.

(2) In this article “county electoral division” means an electoral division established by the County of Warwickshire (Electoral Changes) Order 2004(a).

### **Related alterations of district ward boundaries**

4.—(1) Each area described in column 1 of Table 2 of the Schedule to this Order ceases to be part of the district ward named in column 2 of that Table and becomes part of the district ward named in column 3 of that Table.

(2) In this article “district ward” means a ward established by the District of Stratford-on-Avon (Electoral Changes) Order 2000(b).

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order gives effect to proposals made by Stratford-on-Avon District Council to the Electoral Commission for related alterations of county electoral division and district ward boundaries. These alterations are related to parish boundary changes made by the Stratford-on-Avon (Parishes) Order 2006. The Stratford-on-Avon (Parish Electoral Arrangements and Electoral Changes) Order 2008 also gave effect to proposals made by the Council to the Electoral Commission.

The new boundaries apply in respect of county elections to be held on and after the ordinary day of election of councillors in 2009 and district elections to be held on and after the ordinary day of election of councillors in 2011.

Article 3 alters Alcester, Aston Cantlow, Bidford-on-Avon, Kineton, Stour and the Vale, Stratford Avenue and New Town, and Wellesbourne county electoral divisions.

Article 4 alters Alcester, Bidford and Salford, Ettington, Kineton, Snitterfield, Stratford Avenue and New Town, Tredington, Vale of the Red Horse, Welford and Wellesbourne district wards.
