### The Motor Vehicles (Approval) (Fees) (Amendment) Regulations 2009

The Secretary of State for Transport makes the following Regulations in exercise of the powers conferred by section 61(1) and (2) of the Road Traffic Act 1988(1) and by virtue of the Department for Transport (Fees) Order 2009(2).

In accordance with section 195(2) of the Road Traffic Act 1988 he has consulted with such representative organisations as he thinks fit.

#### Citation and commencement

1. These Regulations may be cited as the Motor Vehicles (Approval) (Fees) (Amendment) Regulations 2009 and come into force on 29th April 2009.

### Amendments to regulation 4 (fees-application for Minister’s approval certificate)

4.—(1) Regulation 4 shall be amended as follows.

(2) In paragraph (1), for sub-paragraph (g), substitute—

“(g) in the case of any new vehicle which satisfies the conditions of regulation 5(8)(b) of the Approval Regulations,  
 (i) £41 if the vehicle is a goods vehicle, and  
 (ii) £38 in any other case.”.

(3) In paragraph (2), for sub-paragraphs (a) to (c), substitute—

“(a) in the case of any Schedule 2 vehicle,  
 (i) £83 if the vehicle is a goods vehicle, and  
 (ii) £76 in any other case;  
 (b) in the case of any vehicle which is not a Schedule 2 vehicle but which is the subject of a model report,  
 (i) £138 if the vehicle is a goods vehicle,  
 (ii) and £127 in any other case;  
 (c) in the case of any vehicle which is not a Schedule 2 vehicle and which is not the subject of a model report,  
 (i) £124 if the vehicle is a goods vehicle, and  
 (ii) £114 in any other case.”.

(4) In paragraph (3), for sub-paragraph (b), substitute—

“(b) the fees prescribed by paragraphs 1(g), 2(b) or (c) shall be increased by—

- (i) £27 in the case of a goods vehicle, and
  - (ii) £25 in any other case.”
- (5) For paragraph (4), substitute—
- “(4) Where an original application is refused by virtue of regulation 10 of the Approval Regulations, the fee prescribed for the purposes of regulation 6(3)(b) of those Regulations shall be—
- (a) £70 in the case of any goods vehicle, and
  - (b) £64 in any other case,”
- and the balance of any sum previously paid in respect of that fee shall be repaid to the applicant.”.

## EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations amend the Motor Vehicles (Approval) (Fees) Regulations 2001 (“the 2001 Regulations”). Those Regulations prescribe the fees payable in connection with applications and appeals under the Motor Vehicles (Approval) Regulations 2001 (S.I. 2001/25) (“the Approval Regulations”). The Approval Regulations allow single vehicles to be approved before they enter into service in terms of their design, construction, equipment and marking.

*Regulation 3* increases the fee to accompany the application for issue of a replacement approval certificate by 8.3% from £12 to £13.

*Regulations 3 and 4* increase the fees for goods vehicles. The increased fees for goods vehicles are set out in the Table (with the percentage increase since the fees were last fixed shown in brackets).

appropriate fee payable under regulation 4 for an application for the issue of a Minister's approval certificate. The fees payable on an appeal are therefore also increased accordingly.

With the exception of the fee to accompany an application for issue of a replacement approval certificate under regulation 9, all other fees for passenger vehicles remain the same.
