The A12 Trunk Road (Vauxhall Roundabout to Pasteur Road Roundabout Great Yarmouth) and the A47 Trunk Road (Old Road Roundabout Acle to Vauxhall Roundabout Great Yarmouth) (Norfolk) (Temporary Prohibition of Traffic) Order 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the A12 Trunk Road ("the A12") and the A47 Trunk Road ("the A47") is satisfied that traffic on those roads at Great Yarmouth in the County of Norfolk should be prohibited because works are proposed to be executed thereon:

NOW THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) hereby makes the following Order:

1. This Order may be cited as the A12 Trunk Road (Vauxhall Roundabout to Pasteur Road Roundabout Great Yarmouth) and the A47 Trunk Road (Old Road Roundabout Acle to Vauxhall Roundabout Great Yarmouth) (Norfolk) (Temporary Prohibition of Traffic) Order 2010 and shall come into force on 13 April 2010.

2. In this Order -

"the A12" means the northbound and southbound carriageways of the A12 between their junctions with the A12/Pasteur Road/Gapton Road Roundabout and the A12/A47 Acle New Road/A149 Runham Road/Vauxhall Roundabout, Great Yarmouth;

"the A47" means the eastbound and westbound carriageways of the A47 between their junctions with the A47/A1064 Old Road Roundabout Acle and the A12/A47 Acle New Road/A149 Runham Road/Vauxhall Roundabout, Great Yarmouth;

"layby" means an area of carriageway intended for the waiting of vehicles and bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**); and in this definition "carriageway" means any way (other than a cycle track) comprised in the trunk road over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"the works" mean resurfacing and ancillary work to the A12 and A47;

"a first works period" means a period of 10 hours starting at 20.00 hours on Wednesday 14 April 2010 or on any subsequent day until the said works to the A12 have been completed;

"a second works period" means a period of 10 hours starting at 20.00 hours on Tuesday 27 April 2010 or on any subsequent day until the said works to the A47 have been completed;

"the first works period" means the period starting at 00.01 hours on Wednesday 14 April 2010 and ending when the said works to the A12 have been completed;

"the second works period" means the period starting at 00.01 hours on Tuesday 27 April 2010 and ending when the said works to the A47 have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- 3. Subject as mentioned in article 4 no person shall cause or permit any vehicle to
 - (a) enter or proceed in
 - (i) the A12, during a first works period,
 - (ii) the A47, during a second works period,
 - (iii) the layby adjacent to the eastbound carriageway of the A12 situated 3.150 kilometres west of the A12/A47 Acle New Road/A149 Runham Road/Vauxhall Roundabout, Great Yarmouth, during the first works period, or
 - (iv) any layby adjacent to the A47, during the second works period.
- **4.** The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to a vehicle being used in connection with the said works or for police, fire and rescue authority, ambulance or traffic officer purposes.
