## **ROAD TRAFFIC**

The A46 Trunk Road (Warwick Bypass) (Link Road) (Temporary Prohibition of Traffic) Order 2010

Coming into force			-	- 26 April 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the A46 Trunk Road ("the A46") and connecting roads, is satisfied that traffic on one of those connecting roads near Warwick in the County of Warwickshire should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) and 122A of the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order:-

**1.** This Order may be cited as the A46 Trunk Road (Warwick Bypass) (Link Road) (Temporary Prohibition of Traffic) Order 2010 and shall come into force on 26 April 2010.

2. In this Order –

"the new trunk road"	means the new trunk road and connecting roads constructed by authority of the A46 Trunk Road (A46/M40 Junction 15 (Longbridge) Bypass) Order 2007( <b>b</b> )	
"Longbridge roundabout"	means the roundabout junction of the A46, the A429 and M40 Junction 15;	
"Sherbourne roundabout"	means the circulatory carriageway of the new trunk road at its roundabout junction with the B4463 and link roads leading to and from Longbridge roundabout;	
"the works period"	means the period starting at 00.01 hours on Monday 3 May 2010 and ending when the said works have been completed;	

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the link road leading from Longbridge roundabout to Sherbourne roundabout.

**4.** The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle -

- (a) being used for police, fire brigade or ambulance purposes;
- (b) proceeding at the direction of, or with the permission of, a police constable; or
- (c) being used for or in connection with the said works.
