## ROAD TRAFFIC

The A46 Trunk Road and the M6 and M69 Motorways (M6 Junction 2, Warwickshire) (Temporary Restriction and Prohibition of Traffic) Order 2010

Made - - - - 23 April 2010

Coming into force - - 30 April 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the M6 Motorway ("the M6"), the M69 Motorway ("the M69"), the A46 Trunk Road ("the A46") and connecting roads is satisfied that traffic on lengths of those motorways and that trunk road and some of those connecting roads near Ansty in the County of Warwickshire should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order:-

**1.** This Order may be cited as the A46 Trunk Road and the M6 and M69 Motorways (M6 Junction 2, Warwickshire) (Temporary Restriction and Prohibition of Traffic) Order 2010 and shall come into force on 30 April 2010.

## 2. In this Order –

"the roundabout" means the circulatory carriageway of the

A46 at its roundabout junction with the

A4600 and the M6 at Junction 2;

"the eastern roundabout" means the circulatory carriageway of the

A46 roundabout east of the M69 overbridge;

"the western roundabout" means the circulatory carriageway of the

A46 roundabout west of the M69

overbridge;

"the works period" means the period starting at 22:00 hours on

Sunday 1 May 2010 and ending when the

said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 6 and 7 no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour on
  - (a) the roundabout;
  - (b) the eastern roundabout;
  - (c) the western roundabout;
  - (d) the northbound carriageway of the A46 from its junction with the M69 to its junction with the western roundabout:
  - (e) the northbound carriageway of the A46 from its junction with the western roundabout to its junction with the roundabout;
  - (f) the southbound carriageway of the A46 from its junction with the roundabout to its junction with the western roundabout;
  - (g) the northbound carriageway and the southbound carriageway of the A46 between the western roundabout and the eastern roundabout;
  - (h) the southbound carriageway of the A46 from its junction with the eastern roundabout for a distance of 160 metres;
  - (i) the link road leading to and from Ansty Business Park from the eastern roundabout for a distance of 70 metres in an easterly direction;
  - (j) the slip road leading from the southbound carriageway of the M6 at Junction 2 from a point 320 metres west of the roundabout to the roundabout;
  - (k) the slip road leading to the southbound carriageway of the M6 at Junction 2 from the roundabout for a distance of 130 metres;
  - (1) the slip road leading from the southbound carriageway of the M69 to the roundabout;
  - (m) the slip road leading from the northbound carriageway of the M6 to the roundabout;
  - (n) the slip road leading to the northbound carriageway of the M6 at Junction 2 from the roundabout for a distance of 25 metres; and
  - (o) the link road leading from the southbound carriageway of the M6 at Junction 2 to the northbound carriageway of the M69 from its junction with the slip road described at (j) above for a distance of 80 metres.
- **4.** Subject as mentioned in articles 6 and 7 no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour on
  - (a) the southbound carriageway of the M6 from the centreline of Longford Viaduct (east of Junction 3) to a point 920 metres east of the centreline of Woodway Lane overbridge;
  - (b) the slip road leading from the southbound carriageway of the M6 at Junction 2 from its junction with the southbound carriageway to a point 320 metres west of the roundabout;
  - (c) the northbound carriageway of the A46 from its roundabout junction with the A428 to its junction with the M69;
  - (d) the northbound carriageway of the M69 from its junction with the A46 for a distance of 250 metres.
  - (e) the southbound carriageway of the M69 from a point 200 metres north of the centreline of Wood Lane overbridge for a distance of 2900 metres; and
  - (f) the northbound carriageway of the M6 from a point 1300 metres west of the A4455 Fosse Way overbridge for a distance of 3800 metres.
- **5.** Subject as mentioned in articles 6 and 7 no person shall, during the works period, cause or permit any vehicle to enter or proceed in -
  - (a) the eastern roundabout;
  - (b) the western roundabout;
  - (c) the northbound carriageway of the A46 from its junction with the M69 to its junction with the western roundabout;
  - (d) the northbound carriageway of the A46 from its junction with the western roundabout to its junction with the roundabout;
  - (e) the southbound carriageway of the A46 from its junction with the roundabout to its junction with the western roundabout;
  - (f) the northbound carriageway and the southbound carriageway of the A46 between the western roundabout and the eastern roundabout;

- (g) the southbound carriageway of the A46 from its junction with the eastern roundabout to its junction with the M69; and
- (h) the link road leading to and from Ansty Business Park from the eastern roundabout for a distance of 70 metres in an easterly direction.
- **6.** The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
  - 7. The provisions of:
  - (a) articles 3, 4 and 5 shall not apply to any vehicle -
    - (i) being used for police, fire brigade or ambulance purposes, or
    - (ii) proceeding at the direction of, or with the permission of, a police constable in uniform; and
  - (b) article 5 shall not apply to any vehicle
    - (i) being used in connection with the said works; or
    - (ii) proceeding in the A46 to or from premises which are accessible for that vehicle from, and only from, that road.
- **8.** The A46 Trunk Road (M6 Junction 2, Warwickshire) (Temporary Prohibition of Traffic) Order 2009(a) and the A46 Trunk Road and the M6 and M69 Motorways (M6 Junction 2, Warwickshire) (Temporary Restriction of Traffic) Order 2009(b) are hereby revoked.
