## ROAD TRAFFIC

The A5 Trunk Road (Near Hinckley, Leicestershire) (Temporary Restriction and Prohibition of Traffic) Order 2010

Made - - - - 4 January 2010

Coming into force - -11 January 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the A5 Trunk Road ("the A5") and connecting roads, is satisfied that traffic on lengths of that road in the Counties of Leicestershire and Warwickshire should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order: -

1. This Order may be cited as the A5 Trunk Road (Near Hinckley, Leicestershire) (Temporary Restriction and Prohibition of Traffic) Order 2010 and shall come into force on 11 January 2010.

## **2.** In this Order:

"the trunk road" means the A5 between its junction with the A47 The Long

Shoot and its roundabout junction with the B4109 and the

M69 (Junction 1);

"the roundabout" means the roundabout junction of the A5 with the A47

Dodwells Road and the B4666;

"layby" means an area of carriageway intended for the waiting of

vehicles and bounded partly by a road marking of the type shown in diagram 1010 in Schedule 6 to the Traffic Signs Regulations 2002(b) and partly by the outer edge of that carriageway on the same side of the road as that on which the marking is placed; and in this definition "carriageway" means any way (other than a cycle track) comprised in a length of the trunk road over which the public have a right of way for the passage of vehicles and which has a

suitable surface for the exercise of that right;

"pedal cycle" has the meaning given in regulation 4 of the Traffic Signs

Regulations and General Directions 2002(b);

"the works period"

means the period starting at 20.00 hours on Monday 18 January 2010 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 7 and 8, no person shall, during the works period, drive any motor vehicle at a speed exceeding 30 miles per hour on the trunk road.
- **4.** Subject as mentioned in articles 7 and 8, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the trunk road.
- **5.** Subject as mentioned in articles 7 and 8, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the layby adjacent to
  - (a) the northbound carriageway of the A5 approximately 300 metres south of its roundabout junction with the road leading to Nutts Lane;
  - (b) the northbound carriageway of the A5 approximately 100 metres south of Wolvey Road; and
  - (c) the southbound carriageway of the A5 approximately 200 metres south of Wolvey Road.
- **6**. Subject as mentioned in articles 7 and 8, no person shall, during the works period, cause or permit any pedestrian or person using a pedal cycle to enter or proceed in the footway adjacent to the roundabout.
- 7. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
  - **8.** The provisions of
    - (a) articles 3, 4 and 5 shall not apply to any vehicle-
      - (i) being used for police, fire brigade or ambulance purposes; or
      - (ii) proceeding at the direction of, or with the permission of, a police officer in uniform, and
    - (b) articles 4 and 5 shall not apply to any vehicle being used in connection with the said works;
    - (c) article 4 shall not apply to any vehicle proceeding in the trunk road to or from premises which are accessible for that vehicle from, and only from, that road, and
    - (d) article 6 shall not apply to any person
      - (i) engaged in police, fire brigade or ambulance activity, or
      - (ii) engaged in activity connected with the works.
