**ENVIRONMENTAL PROTECTION**

**The Producer Responsibility Obligations  
(Packaging Waste) (Amendment) Regulations 2010**

*Made - - - - 25th November 2010*

*Coming into force in accordance with regulation 1(b)*

These Regulations are made by the Secretary of State as respects England, Scotland <sup>M1</sup> and Wales <sup>M2</sup> in exercise of the powers conferred by section 2(2) of the European Communities Act 1972 <sup>M3</sup> and sections 93 to 95 of the Environment Act 1995 <sup>M4</sup>.

These Regulations implement Article 6(1) of Council Directive [94/62/EC](#) on packaging and packaging waste <sup>M5</sup> and section 93(3)(a) of the Environment Act 1995 applies.

The Secretary of State is a Minister designated <sup>M6</sup> for the purposes of section 2(2) of the European Communities Act 1972 in relation to the environment.

A draft of these Regulations has been approved by a resolution of each House of Parliament in accordance with section 93(10) of the Environment Act 1995.
