**The Animal Welfare (Codes of Practice)  
(Appointed Day) (England) Order 2010**

*Made - - - - 18th February 2010*

The Secretary of State, in exercise of the power conferred by section 15(5) of the Animal Welfare Act 2006<sup>(1)</sup>, makes the following Order.

**Citation and application**

1. This Order—
  - (a) may be cited as the Animal Welfare (Codes of Practice) (Appointed Day) (England) Order 2010; and
  - (b) applies in England.

**Appointed Day**

2. The appointed day for the following codes of practice coming into force is 6th April 2010—
  - (a) Code of Practice for the Welfare of Privately Kept Non-Human Primates<sup>(2)</sup>;
  - (b) Code of Practice for the Welfare of Cats<sup>(3)</sup>;
  - (c) Code of Practice for the Welfare of Dogs<sup>(4)</sup>;
  - (d) Code of Practice for the Welfare of Horses, Ponies, Donkeys and their Hybrids<sup>(5)</sup>.
