**The Seeds (National Lists of Varieties)
(Amendment) Regulations 2011**

The Secretary of State and the Welsh Ministers are each designated⁽¹⁾ for the purposes of section 2(2) of the European Communities Act 1972⁽²⁾ in relation to the common agricultural policy of the European Union.

The Secretary of State and the Welsh Ministers (the Welsh Ministers acting only in relation to Wales) make these Regulations in exercise of the powers conferred by section 2(2) of, and paragraph 1A of Schedule 2⁽³⁾ to, the European Communities Act 1972.

These Regulations make provision for a purpose mentioned in section 2(2) of the European Communities Act 1972 and it appears to the Secretary of State and the Welsh Ministers that it is expedient for any reference in these Regulations to any of the following EU instruments to be construed as a reference to that instrument as amended from time to time—

- (a) Commission Directive [2003/90/EC](#) setting out implementing measures for the purposes of Article 7 of Council Directive [2002/53/EC](#) as regards the characteristics to be covered as a minimum by the examination and the minimum conditions for examining certain varieties of agricultural plant species⁽⁴⁾,
- (b) Commission Directive [2003/91/EC](#) setting out implementing measures for the purposes of Article 7 of Council Directive [2002/55/EC](#) as regards the characteristics to be covered as a minimum by the examination and the minimum conditions for examining certain varieties of vegetable species⁽⁵⁾, and
