The Waste (England and Wales) Regulations 2011

PART 6

Duties of planning authorities

General interpretation

16.—(1) In this Part—

“the 1990 Act” means the Town and Country Planning Act 1990 ^{M1};

“the 2004 Act” means the Planning and Compulsory Purchase Act 2004 ^{M2};

“the 2008 Act” means the Planning Act 2008 ^{M3};

“local planning authority” has the same meaning as in 1990 Act;

“mineral planning authority” has the same meaning as in section 1 of the 1990 Act ^{M4};

“planning permission” has the meaning given in section 336 of the 1990 Act ^{M5}.

(2) In this Part, “the planning Acts” means—

(a) the 1990 Act;

(b) the Planning (Listed Buildings and Conservation Areas) Act 1990 ^{M6};

(c) the Planning (Hazardous Substances) Act 1990 ^{M7};

(d) the Planning (Consequential Provisions) Act 1990 ^{M8};

(e) the 2004 Act; and

(f) the 2008 Act.

(3) In this Part, “planning authority” means—

(a) a local planning authority;

(b) a joint committee constituted under section 29 of the 2004 Act;

(c) a person appointed under paragraph 1 of Schedule 6 to the 1990 Act ^{M9};

(d) a government department in respect of its functions under the planning Acts; or

(e) an appropriate authority in respect of its functions under the planning Acts.
