ROAD TRAFFIC

The A414 Trunk Road (A5183 Park Street Roundabout to M1 Junction 7, Hertfordshire) (Westbound) (Temporary Prohibition of Traffic) Order 2013

Made - - - - *16th December 2013*

Coming into force - - *23rd December 2013*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A414 Trunk Road (“the A414”), is satisfied that traffic on a length of that road in the District of St Albans in the County of Hertfordshire should be prohibited because works are proposed to be executed nearby:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984^(a) hereby makes the following Order:-

1. This Order may be cited as the A414 Trunk Road (A5183 Park Street Roundabout to M1 Junction 7, Hertfordshire) (Westbound) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 23rd December 2013.

2. In this Order –

“the trunk road” means the westbound carriageway of the A414 from its junction with the western side of the A5183 Park Street Roundabout, St Albans to its merge point with the entry slip road to the northbound carriageway of the M1 at Junction 7;

“works” mean installation of temporary vertical concrete barrier;

“a first works period” means a period of 10 hours starting at 20.00 hours on Monday 6th January 2014 or on any subsequent day (other than a Saturday or a Sunday) until the works to the trunk road have been completed;

“a second works period” means a period of 10 hours starting at 20.00 hours on Tuesday 11th February 2014 or on any subsequent day (other than a Saturday or a Sunday) until the works to the trunk road have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4 no person shall, during a first works period or a second works period, cause or permit any vehicle to enter or proceed in the trunk road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to any vehicle –

- (a) being used in connection with the works or for traffic officer or winter maintenance purposes,
- (b) being used for police, fire and rescue authority or ambulance purposes, or
- (c) proceeding at the direction, or with the permission, of a constable, or traffic officer in uniform.
