**The Employment and Support Allowance Regulations 2013**

Made - - - - 25th February 2013

Coming into force - - 29th April 2013

A draft of these Regulations has been laid before Parliament in accordance with section 26(1) of the Welfare Reform Act 2007 <sup>M6</sup> and approved by a resolution of each House of Parliament.
