#### Citation and commencement

- 1.—(1) This Order may be cited as the Government Resources and Accounts Act 2000 (Estimates and Accounts) Order 2013.
  - (2) This Order comes into force on 1st April 2013.

#### **Designations**

**2.** A body listed in column 2 of a table in the Schedule is a designated body in relation to the department named in column 1 of that table for the financial year which ends on 31st March 2014.
