The Social Security (Contributions) (Re-rating) Consequential Amendment Regulations 2013

Made - - - - 14th March 2013
Laid before Parliament 15th March 2013
Coming into force - - 6th April 2013

The Treasury make these Regulations in exercise of the powers conferred by sections 117(1) and 175(3) of the Social Security Contributions and Benefits Act 1992(a) and by sections 117(1) and 171(3) and (10) of the Social Security Contributions and Benefits (Northern Ireland) Act 1992(b).

The Secretary of State and the Department for Social Development concur in the making of these Regulations.

This instrument contains only provisions in consequence of an order made under section 141 of the Social Security Administration Act 1992(c) and section 129 of the Social Security Administration (Northern Ireland) Act 1992(d).

Citation and commencement

- 1.—(1) These Regulations may be cited as the Social Security (Contributions) (Re-rating) Consequential Amendment Regulations 2013.
- (2) These Regulations come into force on 6th April 2013 immediately after the coming into force of the Social Security (Contributions) (Re-rating) Order 2013(e).

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations, which come into force on 6th April 2013, amend the Social Security (Contributions) Regulations 2001 (S.I. 2001/1004) ("the principal Regulations"). They are made in consequence of the annual up-rating order made under section 141 of the Social Security Administration Act 1992 (c. 5) and section 129 of the Social Security Administration (Northern Ireland) Act 1992 (c. 8).

Regulation 2 amends regulation 125(c) of the principal Regulations by altering the special rate of any Class 2 contributions payable by share fishermen from £3.30 to £3.35.

A Tax Information and Impact Note has not been prepared for this instrument as it gives effect to previously announced policy and it relates to routine changes to rates, limits and thresholds to a predetermined indexation formula.
