The National Health Service (Mandate Requirements) Regulations 2014

Made - - - - 16th December 2014

Laid before Parliament 9th January 2015

Coming into force - - 1st April 2015

The Secretary of State for Health makes the following Regulations in exercise of the powers conferred by sections 13A(9) and 272(7) and (8) of the National Health Service Act 2006(a).

In accordance with section 13A(1) of that Act, the Secretary of State has published and laid before Parliament the mandate(\mathbf{b}).

Citation, commencement and expiry

- 1.—(1) These Regulations may be cited as the National Health Service (Mandate Requirements) Regulations 2014 and come into force on 1st April 2015.
 - (2) These Regulations cease to have effect at the end of 31st March 2016.

Mandate requirements

2. The requirements set out in paragraphs 2.11 and 2.12 of the mandate to the National Health Service Commissioning Board(**c**) published by the Secretary of State on 11th December 2014 and laid before Parliament on that date(**d**) have effect.
