The Walney Extension Offshore Wind Farm Order 2014 ("the Order")(a), which granted development consent within the meaning of the Planning Act 2008 ("the Act")(b), contained correctable errors within the meaning of the Act.

Before the end of the relevant period, as defined in paragraph 1(6)(a) of Schedule 4 to the Act, the Secretary of State received a written request for the correction of errors in the Order.
