Records and information

Annual return and review

- 77.—(1) The contractor must submit to [FINHS England] an annual return relating to the contract which must require the same categories of information to be provided by all persons who hold contracts with [FINHS England] [F2 and make available to NHS England a digital practice area map].
- (2) [FINHS England] may request a return relating to the contract at any time during each financial year in relation to such period (not including any period covered by a previous annual return) as may be specified in the request.
- (3) The contractor must submit the completed return [F3 and make available the digital practice area map] to [F1 NHS England]
 - (a) by a date which has been agreed as reasonable between the contractor and [FINHS England]; or
 - (b) in the absence of such agreement, before the end of the period of 28 days beginning with the date on which the request was made.
- (4) Following receipt of the return referred to in paragraph (1), [FINHS England] must arrange with the contractor an annual review of its performance in relation to the contract.
- (5) The contractor or [FINHS England] may, if desired, invite the Local Medical Committee (if any) for the area in which the contractor is providing services under the contract to participate in the annual review.
- (6) [FINHS England] must prepare a draft record of the review referred to in paragraph (4) for comment by the contractor and, having regard to such comments, must produce a final written record of the review.
- (7) [FINHS England] must send a copy of the final record of the review referred to in paragraph (6) to the contractor.
