# The Immigration (Designation of Travel Bans) (Amendment) Order 2015

Made----25th February 2015Laid before Parliament27th February 2015Coming into force-6th March 2015

The Secretary of State makes the following Order in exercise of the power conferred by section 8B(5) of the Immigration Act 1971(a).

- **1.** This Order may be cited as the Immigration (Designation of Travel Bans) (Amendment) Order 2015 and comes into force on 6th March 2015.
- **2.** For the Schedule to the Immigration (Designation of Travel Bans) Order 2000(**b**) substitute the Schedule set out in Schedule 1 to this Order.
  - **3.** The instrument listed in Schedule 2 to this Order is revoked.

#### EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Immigration (Designation of Travel Bans) Order 2000 (the "2000 Order") by substituting a new Schedule into the 2000 Order. Any person named by or under an instrument listed in the new Schedule or falling within a description in such an instrument will be excluded from the United Kingdom (subject to the exceptions specified in article 3 of the 2000 Order).

The effect of substituting the Schedule is to add to and delete from the list of designated instruments.
