# The Environment and Rural Affairs (Miscellaneous Revocations) Regulations 2015

Made - - - - 10th March 2015

Laid before Parliament 11th March 2015

Coming into force - - 1st April 2015

The Secretary of State is designated for the purposes of section 2(2) of the European Communities Act  $1972(\mathbf{a})$  in relation to the common agricultural policy( $\mathbf{b}$ ) and the environment( $\mathbf{c}$ ).

The Secretary of State has consulted Natural England and the Historic Buildings and Monuments Commission for England in accordance with section 99 of the Environment Act 1995(**d**).

The Secretary of State makes these Regulations in exercise of the powers conferred by section 2(2) of the European Communities Act 1972, paragraph 8 of Schedule 2 to the Water Act 1983( $\mathbf{e}$ ) and, with the consent of the Treasury, section 56(1) and (2) of the Finance Act  $1973(\mathbf{f})$ .

### Citation, commencement and application

- 1.—(1) These Regulations may be cited as the Environment and Rural Affairs (Miscellaneous Revocations) Regulations 2015 and come into force on 1st April 2015.
- (2) Regulations 2 to 4 apply to England.
- (3) Regulation 5 applies to England and Wales.

2. The Animals and Animal Products (Import and Export) (England) (Laboratories, Circuses and Avian Quarantine) Regulations 2007(a) are revoked.

- (h) the Older Cattle (Disposal) (England) Regulations 2005(i); and
- (i) the Dairy (Specific Market Support Measure) Regulations 2010(j).

## **Environmental protection**

4. The Environmental Protection (Disposal of Polychlorinated Biphenyls and other Dangerous Substances) (England and Wales) (Amendment) Regulations 2000(k) are revoked.

**5.** The Water (Compensation) Regulations 1983(I) are revoked.
