Presumption of conformity **E+W+S**

40.—(1) Pressure equipment or an assembly which is in conformity with a [^{F1}designated] standard (or part of such a standard) ^{F2}... is to be presumed to be in conformity with the essential safety requirements covered by that standard (or that part of that standard).
