F1... Declaration of conformity E+W+S

- **48.** The F2... declaration of conformity in respect of pressure equipment or an assembly must—
 - (a) state that the fulfilment of the essential safety requirements has been demonstrated in respect of pressure equipment;
 - (b) contain the elements specified in [F3Schedule 1A to these Regulations] for the relevant conformity assessment procedure followed in respect of the pressure equipment or assembly; and
 - (c) have the model structure set out in Schedule 11.
