The Personal Injuries (NHS Charges) (Amounts) Amendment Regulations 2016

Made - - - - *10th February 2016*
Laid before Parliament *17th February 2016*
Coming into force - - *1st April 2016*

The Secretary of State makes the following Regulations in exercise of the powers conferred by sections 153(2) and (5) and 195(1) and (2) of the Health and Social Care (Community Health and Standards) Act 2003(a).

In accordance with section 195(3) of that Act, the Secretary of State has consulted the Welsh Ministers(b).

Citation, commencement, application and interpretation

1.—(1) These Regulations may be cited as the Personal Injuries (NHS Charges) (Amounts) Amendment Regulations 2016 and come into force on 1st April 2016.

(2) These Regulations apply to England and Wales.

(3) In these Regulations, “principal Regulations” means the Personal Injuries (NHS Charges) (Amounts) Regulations 2015(c).

Amendment of Schedule 1 to the principal Regulations

2. In Schedule 1 to the principal Regulations (amount of NHS charges), for the table in that Schedule, substitute the following table—

Section 195 was amended by section 6 of, and Schedule 4 to, the National Health Service (Consequential Provisions) Act 2006 (c.43).

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Personal Injuries (NHS Charges) (Amounts) Regulations 2015 (“the principal Regulations”) which make provision about the charges payable under the scheme for the recovery of NHS charges in cases where an injured person who receives a compensation payment in respect of their injury has received NHS hospital treatment or ambulance services.

Amendments made to the principal Regulations by regulation 2, in inserting a substitute table in Schedule 1, increase the charges in respect of injuries which occur on or after 1st April 2016. Where the injured person is provided with NHS ambulance services, the charge is increased from £195 to £201. Where the injured person receives NHS treatment, but is not admitted to hospital, the charge is increased from £647 to £665. The daily charge for NHS in-patient treatment is increased from £796 to £817. The maximum charge in respect of an injury is increased from £47,569 to £48,849.

A full impact assessment has not been prepared for these Regulations as a negligible impact on business, charities or voluntary bodies is foreseen.
