The Secretary of State for Health makes the following Order in exercise of powers conferred by sections 51 and 273(1) of, and paragraph 10 of Schedule 4 to, the National Health Service Act 2006(a).

#### Citation and commencement

**1.** This Order may be cited as the National Health Service Trusts (Trust Funds: Appointment of Trustees) (Revocation) and the NHS Foundation Trusts (Trust Funds: Appointment of Trustees) (Amendment) Order 2017 and comes into force on 1st April 2017.

#### Revocations

**2.** The instruments specified in the Schedule (which relate to the appointment of trustees for National Health Service trusts by the Secretary of State) are revoked.

Article 2 of, and the Schedule to, this Order revoke six statutory instruments relating to the appointment of trustees for National Health Service trusts.

Article 3 of this Order substitutes Schedule 1 to the NHS Foundation Trusts (Trust Funds: Appointment of Trustees) Order 2007 (S.I. 2007/1766) to provide that the only NHS foundation trust for which the Secretary of State must appoint trustees is the University Hospitals Bristol NHS Foundation Trust.
