## EMPLOYMENT, ENGLAND AND WALES

The Gangmasters and Labour Abuse Authority (Complaints and Misconduct) Regulations 2017

Made - - - - 3rd April 2017

Laid before Parliament 6th April 2017

Coming into force - - 30th April 2017

The Secretary of State makes the following Regulations in exercise of the powers conferred by sections 26D(1), (2) and (6) and 105(4) and (5) of the Police Reform Act 2002(1).

In accordance with section 24 of that Act(2), the Secretary of State has consulted with the Independent Police Complaints Commission, such persons as appear to her to represent the views of police and crime commissioners, the Mayor's Office for Policing and Crime, the Common Council, the National Police Chiefs' Council and such other persons as she thinks fit.

In accordance with section 63(3)(b) of the Police Act 1996(3), the Secretary of State has supplied a draft of these Regulations to the Police Advisory Board of England and Wales and has taken into account its representations before making these Regulations.
