2(1)	Description of the types of motor vehicles to which the Directive applies.	The Road Vehicles (Construction and Use (Amendment) Regulations 2017 implements the description of wheeled tractors of category T5. Other description have previously been implemented.
2(2)	Describes vehicles that may be excluded from the scope of application of the Directive.	The Motor Vehicles (Tests) (Amendment) Regulations 2017 transpose the requirements for vehicles operated or used in exceptional conditions and vehicles which are never, or hardly ever, used on public roads. The Goods Vehicles (Plating and Testing) (Miscellaneous Amendments) Regulations 2017 transpose the requirements in relation to specialised vehicles.
2 (3)	Member States may introduce national requirements concerning roadworthiness tests for vehicles registered in their territory.	Transposition SI not required
3	Includes definitions for the purposes of the Directive.	The Motor Vehicles (Tests) (Amendment) Regulations 2017 include the definition of vehicles of historical interest.
4	Member States to ensure vehicles are periodically tested.	Transposition SI not required
5	Minimum requirements concerning roadworthiness tests.	The Goods Vehicles (Plating and Testing) (Miscellaneous Amendments) Regulations 2017 implement the minimum requirements for wheeled tractors of category T5.
6	Content and method of roadworthiness testing for all vehicle categories within the scope of the Directive with the exception of vehicle categories L3e, L4e, L5e and L7e with an engine displacement of more than 125 cm ³ .	The Motor Vehicles (Tests) (Amendment) Regulations 2017
7	Assessment of deficiencies and their level of severity.	Transposition SI not required
8	Member States to ensure that testing centres issue a roadworthiness standard test certificate.	Transposition SI not required.
9	Follow-up of deficiencies identified in the testing process and deeming of vehicles as having passed or failed the test.	Transposition SI not required.
10	The testing centre to provide proof for each vehicle which has passed a test.	Transposition SI not required.
11	Testing facilities and equipment.	Transposition SI not required.

12	Testing centres to meet minimum standards and are authorised by Member States.	Transposition SI not required.
13	Inspectors to be authorised and to meet minimum competence and training requirements.	Transposition SI not required.
14	Member States shall ensure that testing centres are supervised to the extent required.	Transposition SI not required.
15	Member States shall designate a national contact point for exchanging information with the other Member States and the Commission with regard to the application of this Directive.	Transposition SI not required.

They shall immediately inform the Commission thereof.</p> <p>They shall apply those measures from 20 May 2018.</p> <p>When Member States adopt those measures, they shall contain a reference to this Directive or shall be accompanied by such reference on the occasion of their official publication.
