

The Export Control (Amendment) (No.2) Order 2018

Transposition Note

This Transposition Note, in tabular form, explains how the Export Control (Amendment) (No. 2) Order 2018 (“the 2018 Order”) transposes (EU) Directive 2017/853 (“the 2017 Directive”) amending Directive 91/477/EEC (“the 1991 Directive”) on the control of the acquisition and possession of weapons. This table includes some changes made to the firearm control entries in Schedule 2 and 3 of the Export Control Order 2008 (“the 2008 Order”) that are made on a national basis (i.e. as a matter of discretion afforded to Member States under the relevant EU Directives) to help clarify the various firearm controls that are in operation.
