The Parliamentary Elections (Returning Officers' Charges) (Amendment) Order 2019

Made - - - - 18th November 2019

Coming into force in accordance with article 1(1)

The Minister for the Cabinet Office makes the following Order, with the consent of the Treasury(1), in exercise of the powers conferred by section 29(3), (3A) and (4C) of the Representation of the People Act 1983(2) and now vested in the Minister for the Cabinet Office(3).

Citation, commencement and extent

- 1.—(1) This Order may be cited as the Parliamentary Elections (Returning Officers' Charges) (Amendment) Order 2019 and comes into force on the day after the day on which it is made.
 - (2) This Order extends to England and Wales and Scotland.

Amendment to the Parliamentary Elections (Returning Officers' Charges) Order 2019

- **2.**—(1) The Parliamentary Elections (Returning Officers' Charges) Order 2019(4) is amended as follows.
 - (2) In the table in the Schedule (maximum recoverable amounts)—

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parliamentary Elections (Returning Officers' Charges) Order 2019 ("the 2019 Order").

The 2019 Order provides for payments for services and expenses of returning officers in connection with the conduct of parliamentary elections in England, Wales and Scotland. The Schedule to the 2019 Order specifies maximum amounts recoverable by returning officers in each parliamentary constituency in England, Wales and Scotland.

This Order amends the table in the Schedule to the 2019 Order. It substitutes the entry in the table for the constituency of Berwickshire, Roxburgh and Selkirk, as the figures have been revised as a result of further information from the constituency. It also adds a further entry (for the constituency of York Outer) which was omitted in error from the 2019 Order.

This instrument is issued free of charge to all known recipients of the defective instrument.

A full impact assessment has not been produced for this instrument as no, or no significant, impact on the private, voluntary or public sector is foreseen.
