The Trade Marks (Amendment etc.) (EU Exit) Regulations 2019

Citation, commencement and interpretation

- **1.**—(1) These Regulations may be cited as the Trade Marks (Amendment etc.) (EU Exit) Regulations 2019 and come into force on exit day.
 - (2) In these Regulations—

"the 1994 Act" means the Trade Marks Act 1994;

"the Rules" means the Trade Mark Rules 2008 M1.
