In particular, the Regulations address the deficiency specified in section 8(2)(b) of that Act, namely the conferral of functions by retained EU law on, or in relation to, EU entities which no longer have functions in that respect under EU law in relation to the United Kingdom. These Regulations make amendments to retained direct EU legislation in the field of contaminants in food. Part 2 amends retained direct EU legislation for the whole of the United Kingdom.
