#### Citation and commencement

**1.** These Regulations may be cited as the National Health Service Commissioning Board and Clinical Commissioning Groups (Responsibilities and Standing Rules) (Amendment) Regulations 2019 and come into force on 26th April 2019.

# Amendment of the National Health Service Commissioning Board and Clinical Commissioning Groups (Responsibilities and Standing Rules) Regulations 2012

**2.**—(1) The National Health Service Commissioning Board and Clinical Commissioning Groups (Responsibilities and Standing Rules) Regulations 2012(**b**) are amended as follows.

(2) In regulation 20 (interpretation)—

3rd April 2019

- (a) in the definition of "flat rate payment", for "£158.16" substitute "£165.56";
- (b) in the definition of "high band payment", for "£217.59" substitute "£227.77".
