## EXITING THE EUROPEAN UNION PROFESSIONAL QUALIFICATIONS ARCHITECTS EDUCATION, ENGLAND FARRIERS PROVISION OF SERVICES VETERINARY SURGEONS

The Professional Qualifications and Services (Amendments and Miscellaneous Provisions) (EU Exit) Regulations 2020

*Made - - - 24th September 2020* 

Coming into force in accordance with regulation 1

The Secretary of State is designated(1) for the purposes of section 2(2) of the European Communities Act 1972(2) ("the 1972 Act") in relation to recognition of higher education diplomas, formal qualifications, or experience in the occupation, required for the pursuit of professions or occupations.

The Secretary of State makes these Regulations in exercise of the powers conferred by section 2(2) of the 1972 Act, section 8(1) of, and paragraph 21 of Schedule 7 to, the European Union (Withdrawal) Act 2018(3) ("the 2018 Act") and sections 12, 14 and 41(1) of, and paragraph 12 of Schedule 4 to, the European Union (Withdrawal Agreement) Act 2020(4) ("the 2020 Act").
