The Reinforcement to the North Shropshire Electricity Distribution Network Order 2020 ("the Order")(1), which granted development consent within the meaning of the Planning Act 2008 ("the Act")(2), contains correctable errors within the meaning of paragraph 1 of Schedule 4 to the Act.

Citation and commencement

1. This Order may be cited as the Reinforcement to the North Shropshire Electricity Distribution Network (Correction) Order 2020 and comes into force on 29th September 2020.
