

EXPLANATORY MEMORANDUM TO

THE GRANTS TO THE CHURCHES CONSERVATION TRUST ORDER 2020

2020 No. 403

1. Introduction

- 1.1 This explanatory memorandum has been prepared by the Department for Digital, Culture, Media and Sport and is laid before the House of Commons by Command of Her Majesty.

2. Purpose of the instrument

- 2.1 This Order provides the statutory basis for the Government's financial support of the Churches Conservation Trust. The Trust was established in 1969 as the Redundant Churches Fund and is now called the Churches Conservation Trust. The Trust cares for Church of England churches of historic or architectural interest no longer required for regular worship and for which no suitable alternative use can be found. The Government currently provides 66% of the Trust's statutory footing, the remaining 34% being provided by the Church Commissioners.

3. Matters of special interest to Parliament

Matters of special interest to the Select Committee on Statutory Instruments

- 3.1 None.

Matters relevant to Standing Orders Nos. 83P and 83T of the Standing Orders of the House of Commons relating to Public Business (English Votes for English Laws)

- 3.2 This entire instrument applies to England and Wales only.
- 3.3 The instrument does not have any minor or consequential effects outside England and Wales.
- 3.4 In the view of the Department, for the purposes of Standing Order No. 83P of the Standing Orders of the House of Commons relating to Public Business, the subject-matter of this entire instrument (to the extent that it is characterised as being concerned with churches of historic or architectural interest) would be within the devolved legislative competence of the Northern Ireland Assembly if equivalent provision in relation to Northern Ireland were included in an Act of the Northern Ireland Assembly as a transferred matter and the Scottish Parliament if equivalent provision in relation to Scotland were included in an Act of the Scottish Parliament.
- 3.5 The Department has reached this view because this instrument applies only to England and Wales because the Redundant Churches and other Religious Buildings Act 1969 ("the 1969 Act") extends to England and Wales. The instrument does not have minor or consequential effects outside England and Wales.

4. Extent and Territorial Application

- 4.1 The territorial extent of this instrument is England and Wales.

- 4.2 The territorial application of this instrument is set out in Section 3 under “Matters relevant to Standing Orders Nos. 83P and 83T of the Standing Orders of the House of Commons relating to Public Business (English Votes for English Laws)”.
- 4.3 The Church of Wales was disestablished in 1920 as a result of The Welsh Church Act 1914 (1914 [4&5 GEO.5.] c.91). There are a small number of churches in the Welsh counties of Monmouthshire and Radnorshire close to the border with England which are part of the Church of England, having remained attached to parishes in the Diocese of Hereford when the Church of Wales was disestablished.

5. European Convention on Human Rights

- 5.1 Nigel Huddleston, the Minister for Sport, Tourism and Heritage has made the following statement regarding Human Rights:

“In my view the provisions of The Grants to the Churches Conservation Trust Order 2020 are compatible with the Convention rights.”

6. Legislative Context

- 6.1 Section 1(1) and (2) of the 1969 Act provides that the Secretary of State may, with the approval of the Treasury, make grants to the Churches Conservation Trust (formally known as the Redundant Churches Fund) during such period and not exceeding such aggregate amount as specified by Order. In accordance with section 1(4) of the 1969 Act, a draft of the Order was laid before and approved by a resolution of the House of Commons.
- 6.2 Since the 1969 Act was passed, the Government has provided statutory funding to the Trust in line with its policies towards preserving and maximising access to the historic built environment. The Trust’s main objective is the conservation of the churches in its care and those newly vested in the Trust by the Church Commissioners. The Trust will also investigate and find alternative uses of the church buildings where appropriate.
- 6.3 The Secretary of State has decided to extend funding beyond the end of the current order. The new Funding Order will cover the period beginning with 1st April 2020 and ending with 31st March 2021.

7. Policy background

What is being done and why?

- 7.1 Government’s policy is to financially support the work of the Churches Conservation Trust, in line with its general objectives concerning the conservation of the historic built environment. Churches represent a large proportion of the listed buildings in England and Wales. Due to demographic changes and other factors, an average of about 20 Anglican churches per year become redundant, following due process undertaken by the Church Commissioners. While a larger proportion of the churches becoming redundant are either found a new use or are demolished, those considered most architecturally or historically significant are vested in the Trust by the Commissioners.
- 7.2 While the primary objective of the Trust is conservation of the churches in its care, alternative uses are sought where appropriate. It is an aim of the Trust that such alternative use would not only reduce the dependence of buildings on the Trust, thus

releasing funding for other projects, but would also produce benefits in line with the aims and objectives of other Departments in terms of the provision of community facilities, capacity building and support for volunteering, community cohesion and regeneration.

- 7.3 Government funding for heritage church buildings continues to be a priority. Funding for the Trust is part of funding for ecclesiastical heritage buildings which includes the Listed Places of Worship Grant Scheme, The Taylor Review Pilot and funding made available by the National Lottery Heritage Fund.
- 7.4 In July 2017, the General Synod approved the Church of England's contribution to the Trust for the period 1st April 2018 to 31st March 2021. The Department for Digital, Culture, Media and Sport has a funding agreement with the Trust which outlines the Department's requirements for the Trust for the funding period, including how the Trust is expected to contribute to the Department's Strategic Objectives. Agreements are made jointly with the Church Commissioners, and encompass the Commissioners' targets for the Trust.
- 7.5 This instrument provides the authority for funding for a one year period, further to the Chancellor of the Exchequer's announcement in 2019 of a fast-tracked one year Spending Round for 2020-2021.

8. European Union (Withdrawal) Act/Withdrawal of the United Kingdom from the European Union

- 8.1 This instrument does not relate to withdrawal from the European Union / trigger the statement requirements under the European Union (Withdrawal) Act.

9. Consolidation

- 9.1 The instrument revokes the Grants to the Churches Conservation Trust Order 2016 (S.I. 2016/433).

10. Consultation outcome

- 10.1 No consultation has been undertaken given the nature of the instrument.

11. Guidance

- 11.1 No guidance is required to accompany this instrument as its sole purpose is to provide the statutory authority for Government to make grants to the Churches Conservation Trust.

12. Impact

- 12.1 There is no, or no significant, impact on business, charities or voluntary bodies.
- 12.2 There is no, or no significant, impact on the public sector.
- 12.3 An Impact Assessment has not been prepared for this instrument as no impact on the private, voluntary or public sectors is foreseen.

13. Regulating small business

- 13.1 The legislation does not apply to activities that are undertaken by small businesses.

14. Monitoring & review

- 14.1 DCMS and the Churches Conservation Trust have a joint Management Agreement which sets out the priorities for both DCMS and the Church Commissioners, the indicators which will be used to measure performance and the way the organisations work together. The Department also has bi-annual funding meetings with both the Church Commissioners and the Churches Conservation Trust. This legislation will be monitored through these meetings and other regular meetings with the Churches Conservation Trust which monitor financial performance for the purposes of grant funding.
