# **AGRICULTURE**

The Direct Payments to Farmers (Application Deadlines) (Coronavirus) (Amendment) (England) Regulations 2020

Made - - - - at 8.00 a.m. on 14th May 2020

Laid before Parliament at 2.00 p.m. on 14th May 2020

Coming into force - - 15th May 2020

The Secretary of State makes these Regulations under the powers conferred by Article 78(b)(a) of Regulation (EU) 1306/2013 of the European Parliament and of the Council on the financing, management and monitoring of the common agricultural policy in so far as it relates to direct payment schemes.

### Citation, commencement and application

- **1.**—(1) These Regulations may be cited as the Direct Payments to Farmers (Application Deadlines) (Coronavirus) (Amendment) (England) Regulations 2020 and come into force on 15th May 2020.
  - (2) These Regulations extend to England and Wales and apply in England only.

## Amendment of Regulation 809/2014

- **2.**—(1) Commission Implementing Regulation 809/2014 laying down rules for the application of Regulation (EU) No 1306/2013 of the European Parliament and of the Council with regard to the integrated administration and control system, rural development measures and cross compliance(**b**) is amended as follows.
- (2) In Article 13(1), in the first subparagraph, after "each year" insert "except in claim year 2020, when the final dates shall not be later than 15 June".
- (3) In Article 15(2), in the first subparagraph, after "year concerned" insert "except in claim year 2020, when they shall be notified by 30 June".

#### **EXPLANATORY NOTE**

These Regulations amend Commission Implementing Regulation 809/2014 laying down rules for the application of Regulation (EU) No 1306/2013 of the European Parliament and of the Council with regard to the integrated administration and control system, rural development measures and cross compliance ("Regulation 809/2014") insofar as it relates to direct payments in consideration of the situation caused by the coronavirus pandemic. Regulation 809/2014 was incorporated into domestic law insofar as relating to direct payments on exit day under the Direct Payments to Farmers (Legislative Continuity) Act 2020 (c. 2). These Regulations make amendments to change the date by which applications for direct payments for claim year 2020 must be submitted to 15th June 2020 and to change the date by which amendments to such applications may be made to 30th June 2020.

An impact assessment has not been produced for this instrument because there are no additional costs to businesses, charities, voluntary bodies or the public sector.
